

# Waterbury Connecticut Teachers Federal Credit Union (WCTFCU) Teacher Back to School Classroom Supply Gift Card Drawing 2025

NO PURCHASE NECESSARY TO ENTER OR WIN.

## Eligibility:

This Campaign is open to Teachers in our Credit Union field of membership who:

- 1) LIKE One of the “*Teacher Back to School Classroom Supply Drawing*” social media posts on our Facebook, Instagram or X (Twitter) social media pages **AND** complete the following:
- 2) IN THE COMMENTS SECTION of that post: Write your first and last name, school name {*where you are employed*}, AND the school district that you work in.

The campaign begins on August 13, 2025 at 7:00 a.m. Entrants must be 18 years of age or older as of the date of entry.

The Campaign is only open to legal residents of the United States, and is void where prohibited by law. Employees of WCTFCU, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

## Agreement to Rules:

By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decisions of WCTFCU as final and binding as it relates to the content of this Campaign.

## Campaign Period:

Entries will be accepted online starting on August 13, 2025 at 7:00 AM EST and ending at 11:59 PM EST on September 13, 2025.

## How to Enter:

The Campaign must be entered by **Liking AND Adding your first and last name, school name** {*where you are employed*} and **school district**, in the **Comment Section** of ONE of the “*Teacher Back to School Classroom Supply Drawing*” social media posts on one of WCTFCU’s 3 social media channels:

- 1) The Credit Union Facebook page at facebook.com/WCTFCU
- 2) The Credit Union’s Instagram page at instagram.com/wctfcu
- 3) The Credit Union’s X page at twitter.com/WCTFCU

Teachers should be employed at a school in one of the 28 towns within the three CT counties that our Credit Union field of membership covers. For a list of the towns, visit [wctfcu.com/About/contact/membership](http://wctfcu.com/About/contact/membership).

**One entry per person.** The entry must fulfill all campaign requirements, as specified, to be eligible.

Entries that are incomplete or do not adhere to these rules or specifications may be disqualified at the sole discretion of the Credit Union. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the Credit Union.

## Prizes:

Five winners who meet the eligibility requirements, will be chosen at random. Two teachers will each receive one gift card in the amount of \$500. Two additional teachers will each receive one, \$200 gift card and a third teacher will receive one, \$100 gift card.

Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the Winner.

No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted.

**Acceptance of prize** constitutes permission for WCTFCU to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation and that you will sign a release, unless prohibited by law.

Winners agree to pick up gift card at one of the WCTFCU branches and have picture taken with a WCTFCU Representative for purposes of a post on the WCTFCU social media channels.

**Odds:** The odds of winning depend on the number of eligible entries received.

**Winner Selection and Notification:**

Winners will be selected by a random drawing under the supervision of WCTFCU. Winner will be notified by a Credit Union Representative the week of September 15 ,2025.

If Winner cannot be contacted, is ineligible, or fails to claim the prize within a reasonable amount of time deemed by the Credit Union, the prize may be forfeited and an alternate Winner selected.

Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with these terms and conditions and any and all federal, state, and local laws and regulations. Any violation of these Official Rules by Winner (at WCTFCU's sole discretion), will result in Winner's disqualification.

**Terms & Conditions:**

WCTFCU reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond WCTFCU's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign.

In such case, the Credit Union may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by WCTFCU.

The Credit Union reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Official Rules. WCTFCU has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: the use of bots, macros, scripts, or other technical means for entering.

Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Campaign may be a violation of criminal and civil laws. Should such attempt be made, WCTFCU reserves the right to seek damages to the fullest extent permitted by law.

**Limitation of Liability:**

By entering, You agree to release and hold harmless WCTFCU and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the Campaign and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Campaign; (v) electronic or human error in the administration of the Campaign or the processing of entries; (v) misuse or misappropriation of your likeness.
